Chespa Sp. z o.o. hereby announces that, having regard to the protection of human health, the environment and safe use, meets the requirements of the following documents:

Products intended for printing food packaging do not contain raw materials excluded because of classification or detailed description on the list. Specifically excluded are all materials classified as toxic or very toxic (including carcinogenic, mutagenic or toxic to reproduction) in accordance with the list of dangerous substances EC Regulation No. 1907/2006 (REACH). There are not used pigments based on arsenic, cadmium, chromium Cr(VI), lead, mercury, selenium.


